ORDINANCE NO. 170

AN ORDINANCE OF THE TOWNSHIP OF MIDDLE SMITHFIELD, MONROE COUNTY, PENNSYLVANIA, REPEALING ORDINANCE NO. 158 WHICH CREATED A TOWNSHIP PARK AND RECREATION BOARD PURSUANT TO 53 P.S. § 67204 ON FEBRUARY 14, 2008.

WHEREAS, the Board of Supervisors of the Township of Middle Smithfield have heretofore adopted a comprehensive compilation of ordinances of the Township entitled the "Code of the Township of Middle Smithfield"; and

WHEREAS, any and all additions, amendments, deletions, supplements or repeals to the Code, when passed and adopted in such form as to indicate the intention of the Board of Supervisors to be a part thereof, shall be deemed to be incorporated into such Code so that reference to the Code shall be understood and intended to include such changes; and

WHEREAS, whenever such additions, amendments, deletions, supplements, or repeals to the Code shall be adopted, they shall thereafter be printed and, as provided hereunder, inserted in the post-bound book containing said Code as amendments and supplements thereto; and

WHEREAS, Section 1506 of the Second Class Township Code, Act of May 1, 1933, P.L. 103, No. 69, as amended by the Act of November 9, 1995, P.L. 350, No. 60, found at 53 P.S. 66506, entitled "General Powers", authorizes the board of supervisors to take and adopt ordinances necessary for the proper management, care and control of the Township, and the maintenance of the health and welfare of the Township and its citizens; and

WHEREAS, the Board of Supervisors of Middle Smithfield Township deem the Park and Recreation Board to be ineffective, unproductive and unnecessary;


NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors of Middle Smithfield Township, Monroe County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same, to wit:

1. Ordinance No. 158 which created a township Park and Recreation Board pursuant to 53 P.S. § 67204 on February 14, 2008, is hereby repealed.
2. This Ordinance shall take effect five (5) days after the date of its enactment.


