## Note from the Treasurer, Mike Dwyer:

*2016 Budget: No Increase in Township Taxes*

At the December 28, 2015 Board of Supervisors meeting, the Middle Smithfield Township 2016 Annual Budget was unanimously approved. This budget does not include an increase in township taxes, in sewer fees, or in any taxes or fees. General Funds income for 2016 is projected to be higher than 2015, due to the continued growth of our local economy. We are seeing personal income rise and anticipate commercial development to occur in 2016, as we are the only township in Monroe County that has all commercial and industrial properties within a Local Revitalization Tax Assistance Act (LERTA) zone.

The 2016 Budget reflects the township's vision to continue to improve our roads, our parks, our services and many other township amenities. We now have a comprehensive Capital Improvement plan for the entire sewer system and we expect to make long-awaited repairs and necessary upgrades. We continue to look for cost-savings wherever possible, and continue to provide the needed services that our residents and businesses have come to rely on.

The budget for 2016 also reflects our continued aggressive efforts to apply for and receive State grants. Whether from the Department of Environmental Protection (DEP), Department of Conservation and Natural Resources (DCNR) or other grants, we have dedicated volunteers, staff, and professionals working diligently to attain this "free" money.

The willingness of residents and business owners to contribute to the success of our township does not go unnoticed. Those who volunteer their time on our committees are commended. These are the people who want to see our township improve, work as a team, and do not ask for praise.

While we are constantly looking to improve, over the last 4 years, Middle Smithfield Township has undoubtedly taken great strides in becoming a model township for our residents, business owners, and visitors. Our fiscal policies, our eagerness to work with all businesses, and our resident- and business-friendly approach has made, and will continue to make, Middle Smithfield Township the best place to live, work and play throughout the Poconos.

## It'Snow Laughing Matter

As we continue to be in the midst of winter, please drive carefully. Our Public Works Department is out during each storm plowing our roads and spreading treatment so our roads are passible as quickly as possible. Our township is one of the few that uses a treated salt product that works faster and lasts longer. The cost per yard for this material may be a bit more than salt, but we save on manpower, equipment wear and tear, and actually use less material than we would with just salt. Compliments are often received about the conditions of our roads, compared to even State roads and roads that see higher traffic volume.

When plowing is being done, there is no place to put the snow other than the road shoulder. Residents often ask us to avoid their lawn or driveway which is impossible. The maintenance of our roads is necessary to allow for emergency vehicles and motorists to drive safely. One consideration is that when plowing or shoveling your driveway, put as much of the snow to the left of your driveway (looking at your house) so that when plows come down the road, large piles of snow are not pushed back.



We have created a list of helpful hints for winter driving:

- Check the battery and charging system for optimum performance.
- Check the antifreeze
- Check that heaters, defrosters and wipers work properly.
- Check the tire tread depth and tire pressure. Bald tires do not make it up hills very well, no matter how much material is put down on the road.
- Check the oil and filter and be diligent about changing them at recommended intervals.
- Check the brakes.
- Check to see that exterior and interior lights work and headlights are properly aimed.

One final note, in order for the PWD Employees to do the best job possible, stranded vehicles should not be parked on the road during snowstorms. Middle Smithfield Township will have parked vehicles towed at the owners expense.

## 2016 Road Improvement Schedule

In 2012, the Board of Supervisors and Public Works Department established a 10-year Road Improvement Schedule. This schedule, as it implies, plans for improving 10% of the 74-miles of township owned roads each year to accomplish improvements of all of our roads every 10-years. We are a year ahead of schedule! Since 2012, we have actually completed over 45% of our roads and more are scheduled in 2016.

In 2016, we are considering the following improvements:

- Upper Lakeview Drive.....spot pave and tar and chip
- Timber Mountain Drive/  
Marjorie Court.....pave
- Wooddale Road.....tar and chip
- Coolbaugh Road (Crown Point to Park)...tar and chip
- Frutchey Drive.....pave
- Tego Lake.....pave
- Besecker Drive.....pave
- Pocono Drive.....tar and chip

In addition, as always, we will repair and maintain all township roads within the township.

The question you may have are: How can all this get done when the average single family residence in our township pays \$250 or less PER YEAR in municipal taxes? How is all this work funded when 85% of the township pays less than \$450 a YEAR in township taxes? In Pennsylvania, the State taxes fuel. The tax received by the State is distributed to each municipality based on population (15,997) and miles of road (73.38). These funds, known as "Liquid Fuels Funds" have increased over the last few years and, in 2016, we expect to receive over \$490,000. Part of these funds are used to pay for equipment but the primary use is for road materials and labor.

We are always concerned about our roads and make every effort to have them cleared in winter as quickly as possible. As portions of our liquid fuels funds are used to pay for salt, cinders, etc for winter maintenance, we hope that winter will be kind to us and we can pave more roads each year.

We are also pleased to inform our residents and business owners that the Pennsylvania Department of Transportation has committed to paving Route 209, from the Smithfield border to the Pike County line, scheduled for late 2016/early 2017. This improvement, which has likely not been performed in over 2 decades, is long overdue. This paving project will only enhance the pathway project we hope to accomplish in 2017 (but you will have to read another article about that in this newsletter. See "Multimodal..." article on page 7)

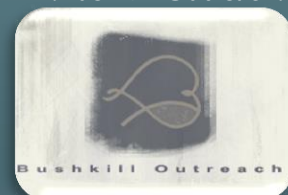

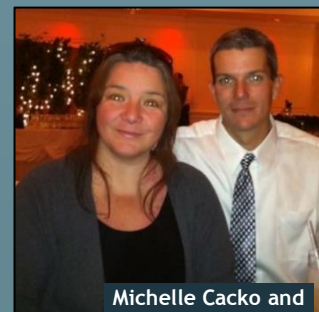
# Two Very Awesome *Finalists*

## Multimodal Transportation Fund Grant Application - 209 Sidepath Project.

Middle Smithfield Township is seeking funds to be used for a Sidepath Project along Route 209 in our township. The Sidepath concept would include the installation of a 6 foot wide pathway for pedestrian and bicycle facilities along the entire length of Route 209 within the Township. This project perfectly complements Penn Dot's 2016 plans to pave 209.

The Multimodal Transportation Fund provides grants to encourage economic development and ensure that a safe and reliable system of transportation is available to the residents of the Commonwealth.

PennDOT provides these grant funds that can be used for the development, rehabilitation and enhancement of transportation assets to existing communities, streetscape, lighting, sidewalk enhancement, pedestrian safety, connectivity of transportation assets and transit-oriented development. Grants are available for projects with a total cost of \$100,000 or more and cannot not exceed \$3,000,000 for any project.

What we have applied for is the maximum \$3,000,000. If awarded, we will proceed with the design and construction of pervious pathways, roughly 6'wide (similar to sidewalks) from the Smithfield township line to Municipal Drive as Phase One, and then apply for this grant again to complete 209 from Municipal Drive to the Lehman township line.

## Middle Smithfield Township PRE-Historical Commission

2015 proved to be an exciting and successful year for the township's Historical Commission. The committee met every goal that was set at the beginning of the year and managed to fit in a couple of unexpected events with great success.

One of the committee's biggest events, Memory Makers, focused on the Flood of 1955 and the resilience of the Pocono spirit. Author, Mary Shafer, was a guest speaker at the event along with other guests who lived through the flood and shared their stories. The event turned out a crowd of about 130 people, making it one of the committee's most memorable events.

The biggest news for the Historical Commission this year was the arrival of the historical marker that will mark the location of where the Marshall's Creek Mastodon was discovered. The fossil was discovered by John W. Leap, his wife Claire, and his employee Paul Strausser on July 5<sup>th</sup>, 1965.

A replica of the foot of the Mastodon can usually be found at the township building, but will be on loan at the Monroe County Public Library from March until May. Also, look for more information coming soon about the May Mastodon Madness Scavenger Hunt. To close out the year and celebrate their accomplishments, the Historical Committee held a holiday luncheon at the township building on Dec. 3<sup>rd</sup>. At this event the historical marker was unveiled and made the front page of the Pocono Record.

Even with the New Year here, remember that you can still see the historical map of the county donated this past year by Mal and Marge Law, of the Pocono Indian Museum, on display at the township building. There are also 2016 Middle Smithfield historical calendars still available for a suggested donation of \$3, which include historical photos of the township, important meeting and event dates and all federal holidays.

The installation of the marker will be announced in the spring of 2016, with a dedication ceremony planned for the fall, around National Fossil Day (October 12).

## MST in the Zone-ing

2015 was a busy and productive year for the Zoning Office. The most widely advertised and anticipated item was the adoption of the new Sign Ordinance. The Zoning Office will be working hard over the next few months to ensure all commercial property owners, as well as the business owners, receive information on the revised Sign Ordinance and its impact on their signage. An inventory will be taken of all signs along the commercial corridor in an effort to clean up the community of non-permitted signs.

The Zoning Office also had a big year for enforcement and property clean up. Many property owners worked with the Zoning Office to bring their property into compliance in 2015. At the same time, the township moved forward on a project that resulted in the demolition of four dilapidated single family dwellings that were both unsightly and unsafe. The Zoning Office is happy to work with all HOAs and POAs in identifying unsafe structures and ensuring the safety of MST residents.

The Economic Development Committee is also working with the Zoning Office to bring information to local realtors that will assist them in filling the vacant properties both in the commercial and residential districts. By making it clear as to what type of business or dwelling can exist on a specific parcel, the property owner or realtor can target a specific audience for either a sale or a rental. This joint effort looks to improve the community overall.

# New Year, New Parks

2015 was a busy year for MST Parks and Recreation with the opening of two brand new township parks. At its new location on Leroy's Lane, the relocated Dog Park remains the township's most-visited park. Expanded parking and improved features such as higher fences, a walking path and available water have brought lots of new pups out to play and hopefully more in 2016. Echo Lake Park was enhanced by the addition of a scenic, nine-hole disc golf course located around the perimeter of the park. Echo Lake Park also celebrated the addition of a beautiful Veterans Memorial, thanks to the efforts of local Eagle Scout Candidate Joe Schuon of Boy Scout Troop 87. Look for announcements on the date of the dedication ceremony in 2016.

Looking ahead into 2016 the Parks and Recreation Committee is planning to support active lifestyles through the addition of playground and fitness at Echo Lake Park and playground equipment at the new Community Garden thanks to the efforts of Parks Board Vice Chair Jenna Componovo. Come out and play with MST Parks and Recreation in 2016!

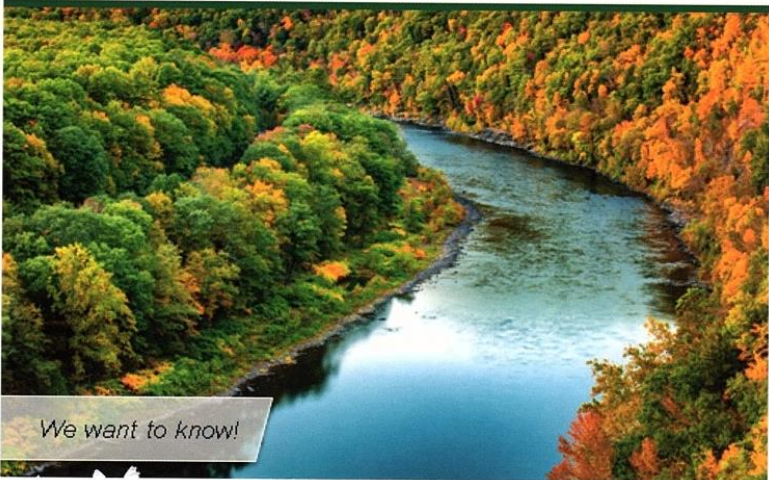
