**TOWNSHIP COMMENTS TO CONSTRUCT A DRIVEWAY
THE FOLLOWING SHALL ALWAYS APPLY:**

1. THE FINISHED HEIGHT OF THE DRIVEWAY SHALL NOT BE ANY HIGHER THAN EXISTING HEIGHT OF SHOULDER.
2. THE TOWNSHIP IS NOT RESPONSIBLE FOR WATER RUNOFF OF RIGHT-OF-WAY ONTO PERSONAL PROPERTY.
3. **ALL DRIVEWAYS SHALL BE LOCATED TEN (10) FEET FROM ANY BORDERING PROPERTY BOUNDARY LINE.**
4. **NOTIFY TOWNSHIP TWO(2) WEEKS PRIOR TO RECEIVING A C/O FOR DRIVEWAY APPROVAL BY TOWNSHIP OFFICIAL.**
5. A PERMIT IS ALSO REQUIRED FOR BLACKTOPPING.

WHEN THE FOLLOWING IS CHECKED OFF BY TOWNSHIP OFFICIAL PROPERTY OWNER MUST COMPLY:

- DRIVEWAY PIPE REQUIRED (AT OWNERS EXPENSE) WHICH ARE INSTALLED ON PROPERTY OWNERS RIGHT OF WAY WITH HEAD WALLS ON EITHER END

- DRIVEWAY PIPE NOT REQUIRED AT THIS TIME DUE TO THE FOLLOWING:
 1. WEATHER CONDITIONS
 2. CONTOUR OF THE PROPERTY
