Ordinance # 249

AN ORDINANCE OF MIDDLE SMITHFIELD TOWNSHIP, MONROE COUNTY, PENNSYLVANIA, AMENDING THE CODE OF ORDINANCES OF MIDDLE SMITHFIELD TOWNSHIP BY AMENDING CHAPTER 61, SALARIES AND COMPENSATION, ARTICLE I, BOARD OF SUPERVISORS, BY INCREASING THE COMPENSATION OF EACH SUPERVISOR IN SECTION 61-1.

WHEREAS, The Pennsylvania Second Class Township Code authorizes the Board of Supervisors to establish the compensation for each Supervisor by ordinance at 53 P.S. 65606; and

WHEREAS, it is the purpose of this Ordinance to provide for an increase in the compensation of Middle Smithfield Township Supervisors in accordance with the limitations provided for in 53 P.S. 65606.

NOW, THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Middle Smithfield Township that the Code of Ordinances of Middle Smithfield Township shall be amended at Chapter 61, Salaries and Compensation, Article I, Board of Supervisors, by increasing the compensation of the Middle Smithfield Township Supervisors at Section 61-1 as follows:

SECTION I

The Code of Ordinances of Middle Smithfield Township is hereby amended at Chapter 61, Salaries and Compensation, Article I, Board of Supervisors, by increasing the compensation of the Middle Smithfield Township Supervisors and amending Section 61-1 to read as follows:

§61-1. Compensation.

For performing the duties imposed by the Second Class Township Code, each Supervisor, elected or appointed to office, shall receive annual compensation in the amount of \$6,915.00. Notwithstanding the foregoing, any such change in salary, compensation, or emoluments of the elected office of Township Supervisor shall not become effective until the beginning of the next term of said office.

SECTION II Repealer.

All other ordinances or parts of ordinances which are inconsistent herewith are hereby repealed, but only to the extent of such conflict.

SECTION III Severability.

If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Supervisors of Middle Smithfield Township that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

ARTICLE IV Effective Date.


This Ordinance shall become effective five (5) days after final enactment.
