Be it RESOLVED, that Middle Smithfield Township ("Township") of Monroe County hereby supports and authorizes the application for a Statewide Local Share Assessment Grant to be used for the Bushkill Volunteer Fire Company Firehouse/Emergency Shelter Renovations.

BE it FURTHER RESOLVED, that the Township requests a Statewide Local Share Assessment Grant of up to \$300,000.00 from the Commonwealth Financing Authority to be used for the above-referenced Bushkill Volunteer Fire Company Firehouse/Emergency Shelter Renovations.

Be it FURTHER RESOLVED, that the Township supports the above-referenced application for a Statewide Local Share Assessment Grant to be used for the Bushkill Volunteer Fire Company Firehouse/Emergency Shelter Renovations subject to the Bushkill Volunteer Fire Company ("Fire Company") being the sub-applicant, as deemed appropriate, and conditional on the Fire Company agreeing to and executing all applications and/or agreements deemed necessary by the Township in relation to the above-referenced grant and project.

Be it FURTHER RESOLVED, that the Township does hereby designate and authorize Annette Atkinson, Chairperson of the Board of Supervisors of Middle Smithfield Township, as the official to execute all documents and agreements between Middle Smithfield Township, the Bushkill Volunteer Fire Company and the Commonwealth Financing Authority deemed necessary to facilitate and assist in obtaining the above-referenced grant.
