**A RESOLUTION OF THE MIDDLE SMITHFIELD TOWNSHIP
BOARD OF SUPERVISORS TO ADOPT THE MIDDLE
SMITHFIELD TOWNSHIP COMPREHENSIVE PLAN UPDATE
2022 (#2).**

WHEREAS, Article III of the Pennsylvania Municipalities Planning Code, (the "MPC") requires municipalities to review and update their comprehensive plan every ten years; and

WHEREAS, pursuant to Section 310.2 of the MPC, the Board of Supervisors of Middle Smithfield Township (the "Board") established a Comprehensive Plan Steering Committee (the "Committee"), whose members, along with members of the Middle Smithfield Township Planning Commission, assisted in the preparation, review, and analysis of the surveys, maps, and studies in order to make recommendations for the preparation of a Comprehensive Plan Update 2022 (#2); and

WHEREAS, the Steering Committee represented various sectors and interests in the Township and held public meetings to receive input on the Comprehensive Plan Update; and

WHEREAS, the Steering Committee, with assistance from Thomas Comitta Associates, Inc., Town Planners & Landscape Architects, and the Monroe County Planning Commission, developed the Comprehensive Plan Update 2022 (#2) titled, "Middle Smithfield Township Comprehensive Plan Update 2022 (#2), dated November 19, 2021, revised June 30 ,2022" (the "2022 Plan (#2)"); and

WHEREAS, pursuant to Section 301(c)(2) and Section 301.3 of the MPC, on July 5, 2022, the Township sent a copy of the 2022 Plan (#2) to the Monroe County Planning Commission ("MCPC") and the MCPC issued its recommendations to the Board in a review letter dated _____, 2022; and

WHEREAS, pursuant to Section 301(c)(2) and Section 301.3 of the MPC, on July 5, 2022, Middle Smithfield Township sent copies of the 2022 Plan (#2) to the governing bodies of contiguous municipalities and the East Stroudsburg Area School District for review and comment; and

WHEREAS, pursuant to Section 302(b) of the MPC, the Board conducted a Public Hearing on the 2022 Plan (#2) on September 8, 2022, pursuant to Public Notice; and

WHEREAS, the Board desires to adopt this Resolution approving and adopting the 2022 Plan (#2).

NOW THEREFORE, the Board of Supervisors of Middle Smithfield Township hereby **RESOLVES**, after considering the recommendations and comments from the Middle Smithfield Township Planning Commission, the MCPC, and the public, and following Public Notice to the School District, adjacent municipalities, and the public, the Board hereby resolves to adopt the 2022 Plan (#2) which is comprised of the maps, charts, textual matter, and all other materials constituting a part thereof, and the said 2022 Plan (#2) is hereby adopted as the Comprehensive Plan Update 2022 (#2) of Middle Smithfield Township.
