

RESOLUTION NO. 09-2022-1

A RESOLUTION OF THE BOARD OF SUPERVISORS OF MIDDLE SMITHFIELD TOWNSHIP, MONROE COUNTY, PENNSYLVANIA, REQUIRING THE ELECTED TAX COLLECTOR TO WAIVE ADDITIONAL CHARGES FOR REAL ESTATE TAXES WHERE NOTICE OF THE REAL ESTATE TAXES WAS NOT RECEIVED FOLLOWING THE TRANSFER OF REAL PROPERTY

WHEREAS, Pennsylvania Act 2022-57 requires municipalities to adopt a resolution or ordinance requiring the Tax Collector to waive Additional Charges for real estate taxes under certain circumstances beginning in the first tax year after the effective date of Act 2022-57; and


WHEREAS, the Board of Supervisors of Middle Smithfield Township, by Resolution, hereby requires the Tax Collector to waive Additional Charges for real estate taxes following the transfer of real property where notice of such taxes was not received.

NOW, THEREFORE, be it hereby **RESOLVED** that


1. The Tax Collector shall waive Additional Charges for real estate taxes in the then current tax year pursuant to Act 2022-57 if the taxpayer does and/or satisfies all of the following:
 - A. Provides a waiver request of Additional Charges to the Tax Collector in possession of the claim within twelve months of a Qualifying Event;
 - B. Attests that a notice was not received;
 - C. Provides the Tax Collector in possession of the claim with any one of the following:
 - i. A copy of the deed showing the date of real property transfer;
 - ii. A copy of the title following the acquisition of a mobile or manufactured home subject to taxation as real estate showing the date of issuance or a copy of an executed lease agreement between the owner of a mobile or manufactured home and the owner of a parcel of land on which the mobile or manufactured home will be situated showing the date the lease commences; and
 - D. Pays the face value amount of the tax notice for the real estate tax with the waiver request.
2. A form providing for the waiver of Additional Charges will be made available at the Middle Smithfield Township Municipal Building.
3. The taxpayer receiving a waiver and paying real estate tax as provided in this subsection shall not be subject to an action at law or in equity for an Additional Charge, and any claim existing or lien filed for an Additional Charge shall be deemed satisfied.


