**A RESOLUTION OF THE BOARD OF SUPERVISORS, MIDDLE SMITHFIELD  
TOWNSHIP, COUNTY OF MONROE, COMMONWEALTH OF PENNSYLVANIA;  
APPROVING THE TRANSFER OF PLCB LICENSE NO. R19967 INTO MIDDLE  
SMITHFIELD TOWNSHIP FROM TUNKHANNOCK TOWNSHIP,  
MONROE COUNTY, PENNSYLVANIA**

**WHEREAS**, Act 141 of 2000, hereinafter the "Act", which amends the Commonwealth of Pennsylvania's Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county, regardless of the quota limitations provided for in Section 461 of the Liquor Code if, as in Middle Smithfield Township, sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

**WHEREAS**, the Act requires the receiving municipality to issue a resolution approving the inter-municipal transfer of the liquor license from outside the receiving township to within its borders prior to submission of an application for such transfer to the Pennsylvania Liquor Control Board; and

**WHEREAS**, amendments to the Liquor Code stipulate that, prior to adoption of a resolution by the receiving municipality, at least one (1) hearing be held for the purpose of permitting interested parties to state their concerns regarding the transfer of the liquor license into the receiving municipality; and

**WHEREAS**, an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of the liquor license into the municipality.

**NOW, THEREFORE, BE IT RESOLVED** that, Saleme Investment Company has properly requested the approval of the Board of Supervisors of Middle Smithfield Township, Monroe County, Pennsylvania for the proposed transfer of Pennsylvania Liquor License Number R19967 by Saleme Investment Company to facilities within Middle Smithfield Township to be located at 4998 Milford Road, East Stroudsburg, Middle Smithfield Township, Monroe County, Pennsylvania from Patrick C. Kenny, LLC located at 3884 Route 115, Blakeslee, Tunkhannock Township, Monroe County, Pennsylvania; and

**BE IT FURTHER RESOLVED** that, the Board of Supervisors of Middle Smithfield Township, Monroe County, Pennsylvania has held a Public Hearing to receive comments on the proposed liquor license transfer and, after consideration of the issues, finds that the transfer of Pennsylvania Liquor License R19967 into Middle Smithfield Township by Saleme Investment Company will result in job creation and revenue enhancement for the residents of Middle Smithfield Township, all of which will substantially benefit the local economy and residents; and

**BE IT FURTHER RESOLVED** that, the Board of Supervisors of Middle Smithfield Township, approves, by adoption of and for the reason stated in this Resolution, the proposed transfer of Pennsylvania Liquor License No: R19967 into Middle Smithfield Township by Saleme Investment Company; and

**BE IT FURTHER RESOLVED** that, transfers, designations and assignments of licenses hereunder are subject to approval by the Pennsylvania Liquor Control Board.

**BE IT FURTHER RESOLVED** that, this approval is conditioned upon final approval of the transfer application of Saleme Investment Company by the Pennsylvania Liquor Control Board.
