WE SINCERELY THANK ALL OF OUR COMMITTEES:

The Economic Development Advisory Committee advises the Board of Supervisors on matters dealing with the advancement and expansion of the local economy. A resource to the business community dedicated to the success of our businesses, the EDC strives to create a diverse business community that is prosperous and innovative while built on a stable economic foundation.

Recognizing the need to reduce costs and manage the golf course operation the current administration inherited, Township officials chartered the **Golf Course Advisory Committee**. This committee helps manage course operations by tending to endless details, and advise Supervisors on golf issues.

The Historical Commission is comprised of historical educators, local residents and committed volunteers that aim to foster and promote public knowledge and interest in Township history. Since its establishment in 2012, members host interactive, fun events such as Marshalls Creek Mastodon events, Memory Makers luncheons and work to procure historical markers for significant sites.

The Parks and Recreation Board's mission is to retain enough open space for our residents' use, maintain the beauty and character of the area, and maintain full functioning park equipment and facilities that will provide a number of recreational activities and events throughout the year. Since the beginning of 2013, the Parks and Recreation Committee have added playgrounds, a community garden, and re-invented the Bark Park. They conduct family friendly events such as the Egg Hunt, Trunk or Treat and Tree Lighting.

The Planning Commission serves as an advisory board that makes recommendations to the Supervisors, Zoning Hearing Board, and to the Zoning Officer. The Commission also reviews all major and minor subdivisions, land development plans and any new zoning changes such as variances or home occupations. The members of the Commission also work on new zoning changes and ordinances.

The Zoning Hearing Board is a quasi-judicial body that renders decisions on specific types of land use appeals and applications. The primary purpose of the zoning hearing board is to help assure fair and equitable application and administration of the zoning ordinance. The zoning hearing board hears appeals from the zoning officer's determinations and grants relief from literal enforcement of the zoning ordinance in certain hardship situations by means of a variance.

A WORD FROM THE TREASURER

As we look to close out 2018, we evaluate our expenses and income and project what will happen in the coming year. In 2018, we forecast that we will end the year in good financial health. Our year to date expenses have been close to what we had budgeted and income is slightly ahead of budget. Some of the positives to note include doubling our interest income, thanks to our Finance Director Ray Wolfe.

We have also seen an increase in Earned Income Tax (that "Berkheimer tax") which means that, in general, our residents are making more money and/or more residents have joined the workforce. With increased income, the Supervisors have been able to increase our annual contributions to each of our Fire and Ambulance Departments. We also enacted an Ordinance this year that will provide a tax credit to these dedicated volunteers and we hope that this will also increase their rosters as volunteers are desperately needed. We also will end the year without taking on more debt, or loans. We have invested in a lot of areas to save us money, such as the new Wooddale salt/cinder storage facility. Now, during storms, we won't spend man hours, equipment, and materials taking the round trip back to the municipal building for more supplies. Another significant contributor to our 2018 income was that our State Representatives championed our grant applications and we were awarded over \$500,000 in grants.

Some of our expenses were lower because of the longstanding partnerships we

have with many residents and business owners. Their support of the many events throughout the year are very much appreciated. The hundreds of volunteers who dedicate some time to events like the Egg-stravaganza, Community Day, Pick Up the Poconos, Restaurant Week, or Tree Lighting, as examples, add to the enjoyment of our community. Seeing so many smiling faces, mostly smiling faces, is what makes our township special. What we do together has undoubtedly caught on, because others are now having similar events in their communities.

While most of the projected expenses for the year are at or close to budget, we did have some overruns that were unforeseen. The major contributor to these expenses was the winter and spring storms. We know that you appreciate the response during storms as we notice you wave to us as we drive by; most even wave with all 5 fingers. It is worth mentioning that each employee is dedicated to minimizing expenses but remain committed to provide the services you require.

So that's the good news. Now for the not-so-good news. (No, it's not about a tax increase, so please keep reading.)

As most of you know, Middle Smithfield became the proud owner of a number of bridges in our township since the EDU purchase in 2010 when the previous administration also accepted Big Ridge Drive along with the Golf Course we are now trying to sell. These buckets of steel have almost reached their anticipated useful life. In 2019 we will need to spend some of our reserves to address the bridges we now own. While reserves will be used to replace the bridge on Village Drive, the Big Bridge, I mean the Big Ridge Drive Bridge, will require

additional funding sources as the current estimate is about \$3,000,000. We will be working with our State Representatives to see if we can get some State or Federal monies.

In 2019 we look forward to a new Community and Cultural Center in Echo Lake Park that will house the Library of the Smithfields. This facility will undoubtedly be a centerpiece in our township and we are pleased to partner with the Eastern Monroe Public Library Board of Trustees and return a full service library back to our township.

So, the current draft of the 2019 Township Budget indicates that there will not be a need for a tax increase. Although we project the use of some of our reserves for our bridges, we expect income to offset the majority of anticipated expenses. The final Budget will be presented at the Supervisors Meeting on December 6th, 2018 at the municipal building at 7:00pm. We will also present the Annual Report at that time.

Thank you to each employee, Supervisor, volunteer, and business owner who have made 2018 such a great success. We are hopeful that 2019 will be even better!

2019: NO MUNICIPAL TAX INCREASE*

The annual presentation of the budget to the public will be Monday, 7pm, December 4th at the township building, along with the 2018 Annual Report.

*Average household in MST pays \$250 or less PER YEAR in municipal taxes, which haven't been increased in 7 years.

LONG TERM SOLUTIONS FOR SHORT TERM RENTALS

We are pleased to that our very own Judy Acosta, Zoning Administrator, was invited by the Pennsylvania State Association of Township Supervisors (PSATS) to present at both their Regional Fall Forum, held on October 9th and 10th in Wilkes-Barre, and their Pennsylvania Association of Zoning Officials (PAAZO) Fall Seminar in Valley Forge on November 8th on the subject of Short Term Rentals.

Considered a pioneer in the area of Short Term Rental management, the township dealt with multiple complaints, enforcement of the zoning ordinance and litigation. The Township used this input and identified opportunities to improve the way Short Term Rentals were addressed. A stand-alone ordinance as well as an amendment to the Zoning Ordinance was adopted in September of 2017. Successfully administering these ordinances and regulation, rather than restriction, of the land use is the goal of the Township and the Zoning Office.

Judy has also participated as an active member of the Pocono Mountain Association of Realtors Short Term Rental Task Force whose primary goal is to foster the conversation on Short Term Rentals in Monroe County and support a county-wide model ordinance. The task force hosted two summits – one in the summer and one in the fall – that were attended by realtors, government officials, homeowners association board members and the public.

LEGISLATIVE CORNER

ANOTHER FIRST: SAFETY FIRST!

On October 25, 2018, Middle Smithfield Township Board of Supervisors passed the first ordinance in Pennsylvania to require Automatic External Defibrillators (AEDs) in certain buildings.

The ordinance requires all newly constructed or substantially renovated buildings in the township with an occupancy load of 50 or more people to have an AED on premises. AEDs will need to be conspicuously located in plain view of the primary public entrance and are easily accessible.

"Part of our task as supervisors is to encourage our businesses to look out for the general population and their employees; this ordinance is something that has been done in a few cities across the country, but not here in Pennsylvania" said township Supervisor Mike Dwyer

"We require fire extinguishers to save buildings. Quite honestly, these AEDs can save lives. I personally believe it's more important to save a life than a building, and if we can do something to encourage that from our businesses, it would be beneficial to everyone." Dwyer added.

"We are thrilled that the Middle Smithfield Supervisors are making a commitment to make their community heart-safe

with this new ordinance." Said Rachel Moyer, President of the The Gregory W. Moyer Defibrillator Fund, Inc. "Not only have they been at the forefront of having AEDs in all of their township buildings but also providing training to all of their employees." Moyer added. "It is so heart-warming that Middle-Smithfield is the first township in Pennsylvania that has taken the lead on this initiative. MST is a positive example of how local leaders can take a strong personal interest in their community; they are a dynamic force of what pro-active looks like."

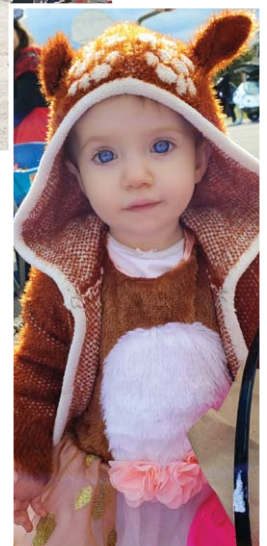

Get ready to skate! Starting in December, our annual Ice Skating Rink will be at W. Leroy Lewis Dog Park.

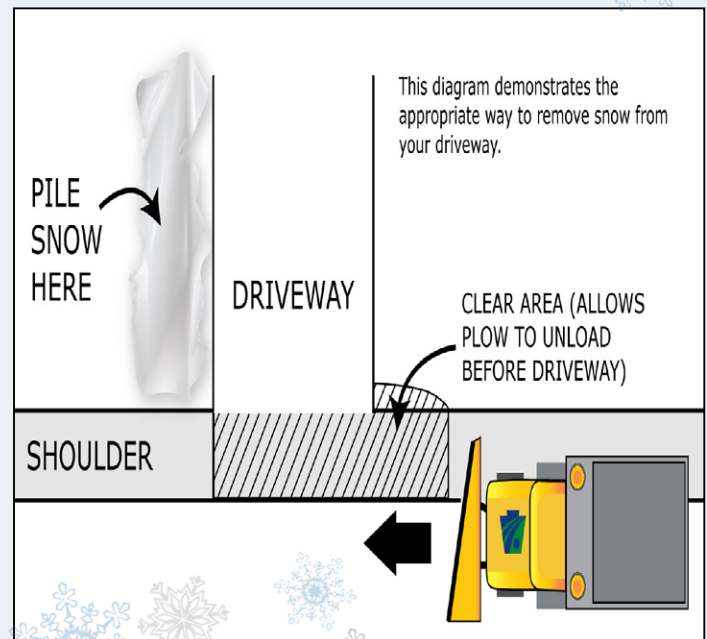
IT'S SNOW LAUGHING MATTER

We are always concerned about our roads and make every effort to have them cleared in winter as quickly as possible. As portions of our liquid fuels funds are used to pay for salt, cinders, etc. for winter maintenance.

Our township is one of the few that uses a treated salt product that works faster and lasts longer. Compliments are often received about the conditions of our roads, compared to State and other township roads.

When plowing is being done, there is no place to put the snow other than the road shoulder. Residents often ask us to avoid their lawn or driveway which is impossible. The maintenance of our roads is necessary to allow for emergency vehicles and motorists to drive safely. One consideration is that when plowing or shoveling your driveway, put as much of the snow to the left of your driveway (looking at your house) so that when plows come down the road, large piles of snow are not pushed back.

WHAT IS "ACT 537"?

On Jan. 24, 1966, the Pennsylvania Sewage Facilities Act (Act 537, as amended) was enacted to correct existing sewage disposal problems and prevent future problems. To meet these objectives, the Act requires proper planning of all types of sewage facilities. The sewage facilities program, often referred to as simply the Act 537 program, is largely administered by individual municipalities (known as local agencies) or groups of municipalities, including County Health Departments (known as joint local agencies). A Major Provision of Act 537 is that all municipalities must develop and implement an official sewage plan that addresses their present and future sewage disposal needs. These plans are modified as new land development projects are proposed or whenever a municipality's sewage disposal needs change. The Department of Environmental Protection reviews and approves the official plans and any subsequent revisions.

Middle Smithfield Township Central Sewer is governed by DEP ACT 537 Special Study. This ACT 537 Special Study states that due to our high quality watershed*, if someone can install a septic mound they must do this first before attempting to join the Central Sewer System along the Sewer System service corridor in the specified, approved sewer service area. In other words: if a property owner's lot has the proper soils (i.e., percs well, drainage for a turkey mound) and meets all other requirements, the property owner must install a septic system instead of connect to the sewer system. This ACT 537 was put in place at a time when the Poconos was experiencing a rapid growth and served to protect the community.

Why do environmentalists prefer septic mounds to sewer plants? Because with a sewer system (unlike a septic mound or spray irrigation) water that is pulled out of the ground for use is not returned to the ground (water table). Instead, the wastewater is sent into a wastewater treatment plant, and released into creeks and rivers -- not returned to the ground. This lowers the water table, and depletes the water supply.

However, in balancing environmental preservation and economic development, the MST Central Sewer has been in the process of trying to amend the ACT 537 Special Study in order to expand where the Sewer Department is permitted to provide sewer services to accommodate the growing and expanding businesses within the Service Corridor on Route 209/Milford Road and to include our Commercial Zone along the Route 402 corridor. Our request to revise our Special Study has now been accepted by PA DEP and we are expecting a ruling in the beginning of 2019.

Why are we doing this? The topography of Route 209/Milford Road limits how deep property owners can expand/construct. In

Upgrade to Pump Station #4:

This project involves replacement of the piping in the wet well and valve vault and a new control panel at pumping station #4 located at 5250 Milford Road in Middle Smithfield Township; Alternate Bids are included for work at Pump Stations #8, and #3. Bids for this project were opened on September 13, 2018 and have been tabled until November 15, 2018.

Bid for crossing Route 209 to install new Sewer main on North bound side:

This project involves the installation of a 12 inch DI Water line and 8 inch PVC Sewer line under US 209 at the intersection of Mt Nebo Road and Milford Road in Middle Smithfield Township. This bid were opened on September 13, 2018 and tabled until November 15, 2018. This project will be paid in part through a grant we received from CFA (Commonwealth Financing Authority) in the amount of \$231,950 to expand the township's sewer line.

other words with wetlands on both sides of 209, there is only so much room for commercial development and expansion is limited to side to side instead of front to back. In order to maximize our 209 commercial corridor (Middle Smithfield's "Main Street"), the proposed revisions to the Act 537 Plan would mean land could be used for commercial development (including stormwater management, such as rain gardens) instead of turkey mounds. As for the C2 area on Route 402, economic development follows amenities (e.g., sewer, water, roads). Expanding sewer capacity in the C2 area on Route 402 would help promote economic development in a different area of the township, and keep congestion off of route 209.

VOICES OF OUR CHILDREN

Have you ever wondered what it would feel like to not be able to use your voice? Is there a time in your life you felt like saying something but were too shy to say it? Do you remember when you heard someone speak to a crowd and were blown away by their speech?

How many times a day do you see or hear something in the media and instantly think to yourself "they read my mind?" Did you ever say to yourself - "I wonder what my mom/dad/friend would have said about this?" (This is very common, especially after we lose a loved one.)

The voices of loved ones are what we remember after they are gone. How many times do you catch yourself saying something your mother/father/child would have said? A familiar phrase.

Each one of us can be a voice for our community, church, country, or better yet -- a Voice for Our Children.

In my platform of reducing the suicide rate of our youth by understanding the mental illness, I have unfortunately met many parents who have lost a child. A child who loses a parent is called an orphan, but there is no name for a parent who loses a child. I always wondered why, until I started meeting a number of parents who had lost their child. There is no name that can describe that amount of grief, sadness, loss, pain, and all the "Why's?" It doesn't matter how they lost their child, the agony is the same for those who lose a child through suicide.

As a mother who almost lost her child to a suicide and depression, my heart breaks every day for those who, unlike me, cannot hug their child anymore. I always struggle with the right words. I didn't realize the magnitude of the undertaking when I decided to make teen suicide my platform when I competed for the title of Mrs. Pennsylvania, United States in May of this year.

I now believe that God was calling me to be a voice for these parents so that they can, in turn, be a voice for their children. I wanted to do something more for them and with them; something that was not just a weekly or monthly grieving parents group. That is how I came up with the group "THE VOICE OF OUR CHILD". My goal is to enable a lost child's legacy to live on through their parents.

How?

I'm creating a website and blog for all these parents to interact and blog about their lost child. These parents can mentor another child going through the same crisis that their own child went

HOLIDAY FIRE SAFETY

Thanksgiving Safety– According to the National Fire Protection Association, (NFPA) Thanksgiving is the leading day of the year for home fires involving cooking equipment. The NFPA recommends the following for kitchen safety on Thanksgiving:

- Stay in the kitchen while you are cooking
- Check food that is being cooked frequently
- Keep children away from the stove and make sure hot liquids and food that could be splashed or cause serious burns is out of reach of children

Make sure all smoke alarms are working

Candle Safety– According to the NFPA most home candle fires happen in the month of December, with 1/3 happening in the bedroom. More than half of candle fires start when things are too close to the burning candle.

The NFPA recommends doing the following to prevent candle fires:

- Blow out all candles when you leave the room or before bed.
- Keep all candles at least 1 foot away from anything that can burn.
- Use sturdy and steady candle holders
- Light carefully and keep away from hair and loose clothing
- Blow candle out before it burns too close to the bottom of the container

Christmas Tree Safety



Christmas Tree Safety— According to the NFPA, one of every three Christmas tree fires in the home is caused by electrical problems. A heat source too close to trees causes roughly one in every four of the fires.

The NFPA recommends the following to prevent Christmas Tree Fires:

- Choose a fresh tree with green needles that do not fall when touched,
- Before placing the tree in the stand, cut 2" from the base of the trunk
- Make sure the tree is at least three feet away from any heat source (fire place, candles, heat vents, etc.)
- Use lights appropriate for Christmas trees that give off little to no heat.
- Replace any lights with broken cords or lose bulbs.
- Read manufacturer's instructions for number of strands to connect.
- Never use lit candles to decorate the tree
- Always turn lights off before leaving the home or going to bed

- ❗ Although Christmas tree fires are not common, when they do occur, they are more likely to be serious.
- ❗ A heat source too close to the tree causes roughly **one in every four** of the fires.

NATIONAL FOSSIL DAY™ & 3RD ANNUAL MARSHALLS CREEK MASTODON EVENT

National Fossil Day was established by the US National Park Service to promote the scientific and educational values of fossils, including the discovery of our Marshalls Creek Mastodon! National Fossil Day is a day to enable children and children-at-heart to better understand the history of life, science of paleontology, and other educational objectives. National Fossil day is in October and this year we celebrated on Wednesday, October 17.

This year Middle Smithfield Residents gathered at the Whispering Pines Banquet Hall to once again experience Mike & Roberta Straka's engaging presentation, the "Dinosaur Dig Show". Mike & Roberta are field paleontologists who have been conducting and managing digs since 1978. Each year they teach paleontology and geology in elementary schools and libraries throughout the tristate area. Their presentation dug into how they discover dinosaurs and they



brought along "Mr. Nixon," an eight foot Triceratops skull that they discovered in 1996, as well as an Albertosaurus skull. The program also included a show & tell portion with rare and unusual fossils. In addition, Mike & Roberta hosted the "Dinosaur Game Show".

After the presentation, guests watched a short video all about our Mastodon, entitled "The Story of the Marshalls Creek Mastodon." On July 5th 1965 John & Claire Leap, along with their employee Paul Strausser, unearthed one of the most complete mastodon skeletons ever found in Pennsylvania. Residents were able to hear the firsthand experiences of the Mastodon discovery and listen to the incredible story about getting the remains to Harrisburg to be displayed in the State Museum.

Residents can visit a Historical Marker issued by the Pennsylvania Historical and Museum Commission for the Marshalls Creek Mastodon near the discovery site, which is right in from of Wendy's on Rt. 209. 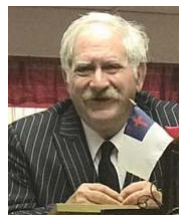


Miguel Barbosa, Chief of Staff, East Stroudsburg University

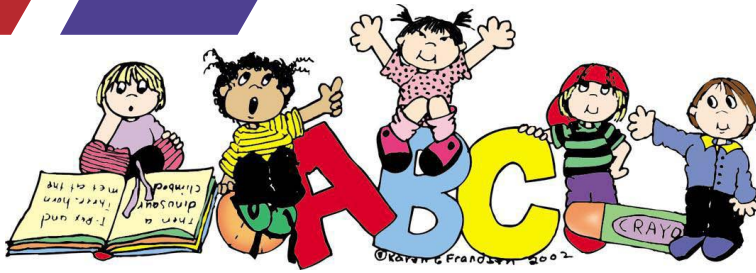

Laura Law is the Director and co-founder of Mady's Angels, the CFO of Law Sound and Lighting, wife to Malcolm Law III and mother to Malcolm Law IV.

Mady's Angels was established in 2011 by Laura and her husband to honor and memorialize their daughter Madyson, who was a selfless and charitable 13 year old. Under Laura's leadership, Mady's Angels has given back over \$150,000 to the community and beyond by directly helping 152 families and supporting more than 51 organizations and causes. These contributions provide scholarships to local high school students, provide families with medical assistance, bereavement support, community outreach, and animal welfare. Mady's Kitchen was also formed at St John's Catholic Church, and feeds about 150 community members every month.



INCREASING ACCESS TO EARLY CHILDHOOD EDUCATION IN MONROE COUNTY

For years, United Way of Monroe County has been supporting early childhood development programs for low-income families in Monroe County. The evidence is clear that access to high-quality pre-K has significant impact for ALL children in schools and has long term, positive educational and economic impact on a community (www.prekforpa.org/case_for_pre-k). All children should have the opportunity to enter school ready to succeed.

A child care desert

As we looked at our work in the early childhood development sector, and at the needs in our community, we noticed a very clear gap in services:

Stroudsburg Area School District had no state-funded high-quality pre-K services. While the state's Child Care Works Subsidized Child Care Program

(CCIS) helps low-income families pay for private child care services, and several providers in Stroudsburg accept these subsidies, but the waiting list is long, with many families not being served.

A research project with ESU showed that 40% of families in Monroe County are not able to afford child care services in our community.

Perhaps even more concerning was that there was a publicly funded program for which many children would be eligible (Pre-K Counts), but no providers were implementing it in Stroudsburg.

The silent partner : Serving as a backbone

Recognizing the value that quality pre-K brings to the education system, the Stroudsburg Area School District (SASD) launched a formal partnership with the United Way of Monroe County last year to bring state-supported high-quality pre-K to the district. United Way of Monroe County assisted the school district in identifying an appropriate location, a 4-STAR early child care provider, and in securing the financial support to be able to bring quality pre-K programming to low-income children in the district. After significant time and effort, the project has come to full fruition.

"The Growing Place Child Care Centers" will be opening its early childhood development doors within the Stroudsburg Middle School this school year. Thirty-six children from low-income families will be accessing high-quality pre-K services through state funding. And another 6 classrooms will eventually open through mixed sources including CCIS, United Way scholarships, and self-pay.

United Way of Monroe County has been privileged to work directly with The Growing Place and the SASD to bring this project to fruition, and is thankful to the numerous individuals and businesses that have come together to make this project a reality, including, but not limited to, the principal donors who are offsetting the start-up costs of this project, including the ESSA Bank & Trust Foundation, the Dale and Francis Hughes Foundation and the Pocono Mountains Community Fundraiser.

More kids on the right track

United Way continues to support early childhood development services in Monroe County, including a new pre-K scholarship program in partnership with Pocono Alliance and our Coins for Kids initiative with WOMEN UNITED. In addition, through our partnership with United Way of Pennsylvania, we are actively engaged in advocacy efforts with the Pre-K for PA initiative, with the goal of expanding access to pre-K programs to children across the state. As a direct result of this work, we are excited about this year's State Budget, which includes increases in support for both Pre-K Counts and Head Start. A significant amount of these funds is now coming back to Monroe County through the great work of The Growing Place and Pocono Services for Families and Children – two critical United Way partners under our Support for Working Families Initiative.
