Members present: Annette Atkinson, Michael J. Dwyer and Mitchell K. Marcus, also in attendance; Township Solicitor Michael Gaul, Township Zoning Officer/Code Official Wayne Rohner, Township Secretary Michele Clewell, Stenographer Donna Kenderdine and several interested parties and residents.

Public Hearing

<u>Dangerous Structure</u> – Dagoberto Mederos, fire damaged home located off Coolbaugh Drive, Lot No. 2 of the Pine Glen Subdivision. Donna Kenderdine took a stenographic record of the public hearing.

Annette Atkinson made a motion to open the public hearing at 6:35 p.m. Mitchell Marcus seconded the motion. Motion passed 3-0.

Attorney Gaul conducted the public hearing on behalf of the Board of Supervisors.

Raymond Ziemba and Don Watson provided testimony.

Wayne Rohner testified in his capacity as the Middle Smithfield Township Zoning Officer/Code Official, whereby exhibits were entered into the record.

Annette Atkinson made a motion to close the public hearing at 6:53 p.m. Mitchell Marcus seconded the motion. Motion passed 3-0.

Annette Atkinson made a motion to order the owner of Lot No. 2 of the Pine Glen Subdivision, PIN #09731602960745 to demolish & remove fire damaged building and authorize the solicitor to prepare a written decision. Michael Dwyer seconded the motion.

Attorney Gaul stated that a sign will be posted on the property if the Board of Supervisors have found the building to be a dangerous structure and the notice is to remain until it is demolished.

Motion passed 3-0.

Solicitors Report

<u>Tesche Minor Subdivision Plan</u> – Attorney Gaul stated that he and the Board of Supervisors received a revised plan today and has not had the opportunity to review it. Ray Rogers stated that the plan contains the language Attorney Gaul required.

Annette Atkinson made a motion to table a decision on the Tesche Minor Subdivision Plan and modification requests until the Board of Supervisors March 28, 2013 7:00 p.m. meeting. Mitchell Marcus seconded the motion. Motion passed 3-0.

Executive Session

Annette Atkinson made a motion to go into executive session at 7:01 p.m. Mitchell Marcus seconded the motion. Motion passed 3-0.

Annette Atkinson made a motion to reconvene the meeting at 7:21 p.m. Mitchell Marcus seconded the motion. Motion passed 3-0.

Approval of Minutes

Annette Atkinson made a motion to approve the February 28, 2013 minutes. Michael Dwyer seconded the motion. Motion passed 3-0.

Report of Executive Sessions

Annette Atkinson reported that an executive session was held prior to this meeting to discuss legal matters before the township.

Committee Reports

- a. <u>Eastern Monroe Regional Park Commission</u> Mitchell Marcus stated that the next meeting will be held on March 18, 2013 at 7:00 p.m. and Intermunicipal agreements will be discussed. (Written report was not provided)
- b. <u>Economic Development Committee</u> Debbie Kulick summarized the EDC monthly report.
- c. <u>Golf Advisory Report</u> Ray White summarized the Golf Advisory Executive Board monthly report.
- d. <u>Historical Commission</u> Annette Atkinson stated that the Historical Commission continues to work on the 501c3 tax exempt sates and 2013 Memory Makers. (Written report was not provided)
- e. <u>Litter & Beautification</u> Ed Regina summarized the Litter & Beautification monthly report.

- f. <u>Parks & Recreation Board</u> Joyce Fenical summarized the Parks & Recreation monthly report.
- g. <u>Planning Commission</u> Annette Atkinson stated that the Planning Commission tabled a decision on the CCP Phase 3 Section 5 PRD plan and they are reviewing the Proposed Floodplain Ordinance. (No written report was provided)
- h. Workers Compensation Safety Committee Mitchell Marcus stated that the next meeting is scheduled for April 11, 2013 at 7:30 a.m. and new members will be voted in. A four hour training course to certify the members will be held at the April 11th meeting. CPR, First Aid and Hazmat training is currently being scheduled. Fire alarms and sprinklers were reviewed; kitchen mats were also to be ordered. Mr. Marcus stated that due to the township creating a safety committee, the Workers Compensation Insurance will be reduced by 5%.

Treasurer's Report

Michael Dwyer reported that we have experienced a number of 2" and 3" winter storms that are just as expensive if not more as the larger snow storms. The expenses are at or close to budget numbers.

A meeting was held with representatives from the Township and PennDOT in order to work on the initial agility agreement, whereby work is traded off between Middle Smithfield Township and PennDOT.

FEMA has also reassured us that we should be receiving our claim monies in the next four to six weeks.

The Monroe County Conservation District has also met with officials from the township regarding utilizing grant monies for specific township roads.

The draft recycling agreement has been forwarded to Lehman and Smithfield Township and a meeting has been scheduled for April 5, 2013 for review.

The 2012 F-450 Ford dump truck with plow was delivered and will be paid out of the general funds which will be reimbursed through the Liquid Fuels Fund.

<u>Approval of Payables</u> – Michael Dwyer made a motion to pay the general fund payables in the amount of \$206,206.49. Mitchell Marcus seconded the motion. Motion passed 3-0.

Michael Dwyer made a motion to pay the (5) EMS providers a total of \$44,457.55. Mitchell Marcus seconded the motion. Motion passed 3-0.

Michael Dwyer made a motion to pay the sewer payables in the amount of \$240,304.74. Mitchell Marcus seconded the motion. Motion passed 3-0.

Michael Dwyer made a motion to pay the golf course payables in the amount of \$8,921.65. Mitchell Marcus seconded the motion. Motion passed 3-0.

Michael Dwyer made a motion to pay the liquid fuels payables in the amount of \$24,695.53. Mitchell Marcus seconded the motion. Motion passed 3-0.

Monroe County Assessment Office; Tax Refunds – Michael Dwyer made a motion to refund Youri & Marina Chipiga \$87.55. Mitchell Marcus seconded the motion. Motion passed 3-0.

New Business

<u>Clubhouse Rental Agreement for Township Employees</u> – Annette Atkinson made a motion to adopt the rental agreement for township employees. Mitchell Marcus seconded the motion. Motion passed 3-0.

<u>Newly Hired Employees</u> – Annette Atkinson made a motion to hire Steve Stein and John Beniamino retroactively to March 4, 2013 for golf course maintenance. Mitchell Marcus seconded the motion. Motion passed 3-0.

Public Comment

Richard Kawski stated that there is a hazardous house at the bottom of his road and asked what can be done. Annette Atkinson stated that the Monroe County Vector Control should be contacted and if he feels strongly he should file a complaint with the township zoning officer/code official.

Oscar Woerlien asked about the digital sign conditional use public hearing. Michael Dwyer stated that the hearing was continued to March 20, 2013.

John Davis asked about the HOA meeting that the township sponsored. Michael Dwyer answered Mr. Davis's questions.

Anthony Valentino asked if the township was going to alert/notify residents through social media of emergencies. Annette Atkinson said yes and we are currently looking into this.

Annette Atkinson made a motion to adjourn he meeting at 8:07 p.m. Mitchell Marcus seconded the motion. Motion passed 3-0.
