PUBLIC HEARING NOTICE

The Board of Supervisors of Middle Smithfield Township, Monroe County, Pennsylvania, hereby gives public notice of its intention to consider for adoption, and if appropriate adopt, the following proposed Ordinance at its regularly scheduled meeting to be held on September 24, 2015, at 7:00 p.m., in the Township Municipal Building, 147 Municipal Drive, East Stroudsburg, Pennsylvania. A public hearing will be held at the aforesaid meeting to consider the proposed Ordinance, and all interested persons are hereby given notice to attend the meeting and to offer such testimony in relation to the proposed Ordinance as they desire. The title and summary of the Ordinance is as follows: AN ORDINANCE OF THE TOWNSHIP OF MIDDLE SMITHFIELD, MONROE COUNTY, PENNSYLVANIA, SETTING FORTH AN AMENDMENT TO THE CODE OF ORDINANCES OF THE TOWNSHIP OF MIDDLE SMITHFIELD, AS HERETOFORE AMENDED, AMENDING PART II, "GENERAL LEGISLATION", CHAPTER 200 "ZONING", ARTICLE IX "SIGNS", DIVISION 90 "SIGN PROVISIONS", AND CONSTITUTING A COMPREHENSIVE REVISION OF THE EXISTING DIVISION 90 "SIGN PROVISIONS"; AND PROVIDING FOR OTHER MISCELLANEOUS MATTERS. The proposed Ordinance comprehensively amends and restates the sign provisions in the Township's Zoning Ordinance, including, without limitation, purposes and applicability, definitions and interpretation, administration, permit procedures, exempt signs, prohibited signs, signs not requiring permits, allowed signs in each zoning district, general standards, criteria and requirements for signs, off-premises and on-premises signs, provisions on miscellaneous signs, sign illumination, non-conforming signs and other miscellaneous matters. A complete and true copy of the proposed Ordinance is on file and may be examined, without charge or obtained for a charge no greater than the cost of reproduction, by the public at the Middle Smithfield Township Municipal Building, 147 Municipal Drive, East Stroudsburg, Pennsylvania, during the hours of 8:00 a.m. to 4:00 p.m. Monday through Friday.
