

## MIDDLE SMITHFIELD TOWNSHIP FEE SCHEDULE

### RESOLUTION NUMBER: 04-2014-1

WHEREAS, pursuant to the Pennsylvania Second Class Township Code, and other various statutes of the Commonwealth, and as permitted by various Chapters of the Code of the Township of Middle Smithfield, the Township may impose fees in connection with various Township services and activities.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of the Township of Middle Smithfield that the following Township fees, as set forth below, are hereby established and/or confirmed, as may be applicable:


**Continuation of Other Existing Fees**


