PUBLIC NOTICE BID NOTICE MIDDLE SMITHFIELD TOWNSHIP MONROE COUNTY, PENNSYLVANIA Middle Smithfield Township desires to purchase sixty (60) gas powered golf carts and one (1) beverage cart for use at its municipal golf course, commonly known as the Country Club of the Poconos. The Township will receive sealed Bids for the sale of such carts until 4 p.m. October 24, 2019. Bids must be delivered to the Office of the Township Secretary located at the Township Building, 147 Municipal Drive, East Stroudsburg Pennsylvania, during regular business hours, Monday through Friday, 8 a.m. to 4 p.m. The Bids will be opened and read at a regular meeting of the Township Board of Supervisors, to be held on October 24, 2019, at 7 p.m. at the Township Building. Bids may be mailed, sent overnight delivery, or hand delivered, but, in each case, must be received at the Office of the Township Secretary no later than the deadline for the receipt of Bids, and properly marked. Bids may not be sent by either fax or electronic mail. A copy of the contract Bid Documents including specifications, will be on file and open to public inspection at the Office of the Township Secretary, at the Township Building, during regular business hours, or be mailed, faxed, e-mailed to a Bidder at the Bidder's request. No interpretation of the meaning of the Bid Documents will be made to the Bidder orally. Envelopes containing Bids must be marked prominently on the outside as follows: "Bid for Sale of Gas Powered Golf Carts" Bids must be made on forms supplied by the Township. Bids will be awarded on the basis of the lowest responsible Bid. The Township reserves the right to reject any and all Bids or parts thereof, and to waive any technical defects or irregularities, as it deems in the best interest of the Township. Bids may be held by the Township for a period not to exceed thirty (30) days from the date of the opening of Bids. Bidder must deliver the specified carts within twenty (20) days of notice of contract award. The Township also reserves the right, as the interests of the Township may require, to revise or amend the Bid Documents prior to the date set for the opening of bids, with such revision to be announced by Addendum to the Bid Documents and copies of all such Addendum issued to be sent to all parties receiving copies of the Bid Documents and be considered as part of the Bid Documents. The Township reserves at its sole discretion the right to select the appropriate bid for the Township. The Township Board of Supervisors will award the contract at its regular meeting on October 24, 2019, or such later meeting publicly announced at the October 24th meeting, or advertised in accordance with the Second Class Township Code.
