**A RESOLUTION OF THE MIDDLE SMITHFIELD TOWNSHIP BOARD OF  
SUPERVISORS, COUNTY OF MONROE, PENNSYLVANIA, APPOINTING ONE  
ALTERNATE MEMBER TO THE MIDDLE SMITHFIELD TOWNSHIP PLANNING  
COMMISSION**

WHEREAS, Article II, Section 203, as amended by the Act of October 7, 2015, P.L. 176, of the Municipalities Planning Code ("MPC"), found at 53 P.S. Section 10203, provides for the appointment of alternate members to the township planning commission to substitute for any absent commission members, for members needing to recuse themselves, or any member that may have been disqualified; and

WHEREAS, pursuant to 53 P.S. Section 10203(e), the term of office of an alternate planning commission member shall be for four years; and

WHEREAS, pursuant to Section 50-2(B) of the Middle Smithfield Township Ordinances, the Board of Supervisors shall appoint at least one, but no more than three, resident(s) of the Township of Middle Smithfield to serve as an alternate member(s) of the Middle Smithfield Township Planning Commission; and

WHEREAS, the Middle Smithfield Township desires to appoint one (1) resident of the Township of Middle Smithfield as an alternate member of the Township Planning Commission to substitute for any absent member of the Planning Commission, for members needing to recuse themselves, or any member that may have been disqualified; and

WHEREAS, the term of office of the alternate member shall be four years.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of Middle Smithfield Township, Monroe County, Pennsylvania, and it is hereby resolved as follows:

SECTION 1: Alternate member of the Middle Smithfield Township  
Planning Commission.

Carrie Wetherbee, a current resident of Middle Smithfield Township, is hereby appointed as an alternate member of the

Middle Smithfield Township Planning Commission to a four-year term of office.

Section 2: Severability.

The provisions of this Resolution shall be severable, and if any of the provisions hereof shall be found to be invalid or unenforceable, the remaining provisions shall remain in effect.

Section 3: Construction.

Any Ordinance in conflict with this Resolution shall take precedence to this Resolution. Any resolution conflicting or inconsistent with any of the provisions in this Resolution is hereby repealed, but only insofar as it is inconsistent.


Section 4: Effective Date.

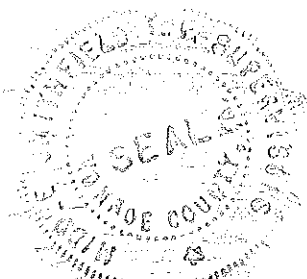
This Resolution shall be effective immediately and shall remain in effect until modified, revoked, or repealed by further Resolution of the Board of Supervisors.


