NOTICE OF PUBLIC HEARING AND INTENTION TO ADOPT  
ORDINANCE

The Board of Supervisors of Middle Smithfield Township, Monroe County, Pennsylvania, hereby gives public notice of its intention to consider for adoption, and if appropriate adopt, the following proposed Ordinance at its regularly scheduled meeting to be held on Monday December 4, 2017, at 7:00 p.m., in the Township Municipal Building, 147 Municipal Drive, East Stroudsburg, Pennsylvania. A public hearing will be held at the aforesaid meeting to consider the proposed Ordinance, and all interested persons are hereby given notice to attend the meeting and to offer such testimony in relation to the proposed Ordinance as they desire. The title and summary of the Ordinance is as follows:

**AN ORDINANCE OF THE TOWNSHIP OF MIDDLE SMITHFIELD, MONROE COUNTY, PENNSLVANIA, SETTING FORTH AN AMENDMENT TO THE CODE OF THE TOWNSHIP OF MIDDLE SMITHFIELD BY AMENDING IN ITS ENTIRETY CHAPTER 48, ENTITLED "PENSIONS", OF PART I, ADMINISTRATIVE LEGISLATION; ELECTING TO AMEND THE TOWNSHIP'S MUNICIPAL PENSION PLAN ADMINISTERED BY THE PENNSYLVANIA MUNICIPAL RETIREMENT SYSTEM PURSUANT TO ARTICLE IV OF THE PENNSYLVANIA MUNICIPAL RETIREMENT LAW; AGREEING TO BE BOUND BY ALL PROVISIONS OF THE PENNSYLVANIA MUNICIPAL RETIREMENT LAW AS AMENDED AND AS APPLICABLE TO MEMBER MUNICIPALITIES; AND PROVIDING FOR OTHER MISCELLANEOUS MATTERS.**

The proposed Ordinance authorizes an amendment of the Township pension plan; approves an amended pension plan contract with the Pennsylvania Municipal Retirement System; accepts the financial obligations of the contract and assumes liability for unfundedness; and provides for miscellaneous other matters. The proposed Ordinance approves changes to the Township's pension plan in the following respects: (1) Any Plan Member who has reached normal retirement age may apply for and begin receiving retirement benefits without the termination of employment. (2) Any re-employed retirees may elect to continue receiving benefits and not rejoin the Plan as an active member. The foregoing is only a summary of the proposed Ordinance. Interested persons are encouraged to review the full text of the proposed Ordinance.

A complete and true copy of the proposed Ordinance is on file and may be examined, without charge or obtained for a charge no greater than the cost thereof, by the public at the

Middle Smithfield Township Municipal Building, 147 Municipal Drive, East Stroudsburg, Pennsylvania, during the hours of 8:00 a.m. to 4:00 p.m., Monday through Friday. A copy of the proposed Ordinance is also available for inspection at the newspaper publishing this legal notice and the Monroe County Law Library.

This Notice supersedes the Notice originally published on the same subject on November 21, 2017.
