**A RESOLUTION OF THE TOWNSHIP OF MIDDLE  
SMITHFIELD, MONROE COUNTY, PENNSYLVANIA  
ADOPTING THE MIDDLE SMITHFIELD TOWNSHIP  
COMPREHENSIVE PLAN UPDATE 2022 (#2)**

**Whereas**, the Board of Supervisors of the Township of Middle Smithfield, Monroe County, Pennsylvania (“Township”) adopted the Comprehensive Plan Update 2007 of Middle Smithfield Township, Monroe County, Pennsylvania by way of Resolution No. 2008-02-1 on or about February 14, 2008 (hereinafter referred to as “2007 Comprehensive Plan”); and

**Whereas**, the Township adopted the Comprehensive Plan Update 2022 of Middle Smithfield Township, Monroe County, Pennsylvania by way of Resolution No. 01-2022-4 on or about January 27, 2022 (hereinafter referred to as “2022 Comprehensive Plan”); and

**Whereas**, the Board of Supervisors of the Township of Middle Smithfield recognized the need to further revise and update the 2022 Comprehensive Plan; and

**Whereas**, the 2022 Comprehensive Plan has been reviewed and updated under the direction of a committee of representatives from Middle Smithfield Township with the assistance of Thomas Comitta Associates, Inc. (“TCA”), and a copy of the Middle Smithfield Township Comprehensive Plan Update 2022 (#2) is attached hereto and marked as *Exhibit “A”* (hereinafter referred to as “Comprehensive Plan Update 2022 (#2)”); and

**Whereas**, the Board of Supervisors of Middle Smithfield Township has complied with the required elements, notice, and adoption procedures of the Pennsylvania Municipalities Planning Code, as amended, in relation to the consideration, approval, and adoption of the Comprehensive Plan Update 2022 (#2); and

**Whereas**, the attached Comprehensive Plan Update 2022 (#2) consists of a bound volume entitled “Middle Smithfield Township Comprehensive Plan Update 2022 (#2)” dated June 30, 2022, including all maps, charts and illustrations.

**NOW, THEREFORE**, be it Resolved and Enacted by the Board of Supervisors of the Township of Middle Smithfield that the attached Middle Smithfield Township Comprehensive Plan Update 2022 (#2), dated June 30, 2022, marked as *Exhibit “A”*, is hereby approved, enacted, and adopted by the Board of Supervisors of the Township of Middle Smithfield.

1. The Board of Supervisors of Middle Smithfield Township hereby adopts the Middle Smithfield Township Comprehensive Plan Update 2022 (#2) that is attached hereto and marked as *Exhibit “A”* as an update to the previously adopted 2022 Comprehensive Plan.

2. This Resolution shall become effective immediately.

3. All resolutions or parts of resolutions inconsistent herewith are hereby repealed to the extent of the inconsistency.

4. If any section, paragraph, sub-section, clause or provision of this Resolution shall be declared invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of this Resolution as a whole or any part thereof other than that portion specifically declared invalid.
